# Aquatic Invasive Species(AIS)

There has been a lot of attention given to quite a few different invasive species thisyear. Boat landing inspections of boats has become widespread. Fines for boaters transporting attached aquatic weeds, bilge water, and live-well water have doubled up to as much as \$1000. Lake Service Providers, who put in and take out our docks and boatlifts, have had to be trained and licensed.

Our Ida Lake Association, in cooperation with Ida Township, has jointly provided inspectors throughout the season at our boat landings using a Minnesota DNR grant. The inspectors have checked boats and trailers for AIS and provided information to boaters using our lake. We do not have the statistics yet on how many boats have been inspected nor how many, if any, violations have been found, but we will report these as soon as we have that information.

# Zebra Mussels

A lot of residents are concerned about the potential zebra mussel threat. Zebra mussels have been found in many area lakes. The above mentioned inspections help prevent the spread of zebra mussels and other invasive pests. Preventive measures are a lot less expensive than curing the problems later. Pictures of the Zebra Mussel are included. #### **Curly Leaf Pond Weed**

This noxious weed has been physically removed in infected areas by several resident volunteers for the past 2 years, but it has migrated to nine additional properties. Next Spring that limited area on the northwest of Little Ida Bay, which has been approved by those residents and the DNR, will be chemically treated with funds from a DNR grant. We will have a booklet of photos at the annual meeting to help you identify this AIS.

## Army Worms (Forest Tent Caterpillars)

In most areas of the lake, Army Worms were not severe this year, but there were pockets around the lake where they were more prominent. Several residents were very unhappy that we didn't spray this year after having done so for the previous three years.

Spraying for Army Worms has become very controversial for legal reasons. We have, over the past three years, received written approval by most, but not all, owners for spraying. This makes the spraying of only authorized lake lots very difficult to do and has the potential to become a huge legal issue.

Your district directors voted unanimously to no longer provide army worm spraying. Ida Lake Association will continue to provide information so individuals and/or groups of neighbors who agree on treating Army Worms can do so themselves. We are currently having discussions with an insect control company about the possibility of them providing individual property owners or districts with army worm control. An update on this research will be presented at the Annual Meeting.

#### **Shoreline Preservation**

The quality of Lake Ida's water is generally above average, as reported in the June, 2011 ILA newsletter. To maintain and improve this precious asset, we need to take measures to help all we can. Burning yard waste near the lake, and unnecessary mowing, fertilizing, and spraying chemicals are detrimental to our lake. Recreational campfires are fun and are allowed, and nice green lawns are also beautiful, but please do consider the alternatives.

## **Burning Regulations**

It is illegal to burn within 100 feet of the ordinary high water level of the lake, except for recreational campfires which do not require a permit but need to be no more than three feet in diameter and three feet tall. Any other burning does require a permit, but county burning restrictions may still be in place. See the DNR Burning Permits Information website: http://www.dnr.state.mn.us/forestry/fire/

#### **Shoreline Restoration**

Several homes around Lake Ida have stepped forward and are participating, with the Douglas County Soil and Water Conservation District, to improve the lakeshore on their property and to help prevent erosion with the use of native plantings. There are grants available with the Clean Water Legacy Fund which will pay up to 75% of the cost for approved projects.
