


## **2015 Spring Annual Meeting**

#### **Protect Our Waters**

Everyone has heard of aquatic invasive species (AIS), but not everyone remembers what they can - and must - do to follow the law. We need

everyone who enjoys Minnesota's vast water resources to get on board and help stop the spread of AIS. Prevent the transport of zebra mussels. Eurasian watermilfoil and other aquatic invasive species (AIS). Invasive species are species that are not

native to Minnesota and cause economic or environmental harm or harm to human health. Minnesota waters are threatened by aquatic invasive species. It is illegal to transport any aquatic plants, zebra mussels, New Zealand

mudsnails or other prohibited invasive species, or to launch a boat or trailer with these species attached.

Studies have shown that the lakes being effected are a long a path, following the major thoroughfares through Minnesota, in other words, we as humans are the cause of the spread of AIS. We bring it with us as we drive from lake to lake!

Boaters are required to complete three main actions before leaving the access. 1 - Clean off the

boat by removing all plants, mud, debris and organisms from the exterior and of interior the boat (including angling equipment and the anchor). 2 - Drain all water from the boat and other water related equipment, including bait water. 3 - Pull the plug (it



must remain out during transport).

Ida Township received a grant of \$4,000 for monitoring the Lake Ida boat accesses for the 2015 season. There will be four trained people providing 400 hours of lake access monitoring.

#### **From Your President**

A normal ice out date and crappies are biting, awesome! The beginning of another great Lake Ida summer! I sincerely hope many memories for us all to cherish. Over the past year I have been totally amazed by the willingness of people in the association to give of themselves.

Lower water levels will make it possible to repair the dam. And it has! Dean Beck from the DNR was pleased to report that the new aluminum stop logs are now in place in the Lake Ida dam. Turned out a bad plank on the west side was made of concrete. The swinging finger barriers are also back in place. The lower water level will allow us to hold the July 4<sup>th</sup> Boat Parade this year and I look forward to seeing you.

We, the association need to get creative in fundraising for walleye stocking. The great walleye fishing in the 1980's was a direct result of massive stocking. There were 3,000 pounds per year for 3-years stocked. If the association were to attempt this we would need to raise \$ 30,000.00 per year. I would rather be discussing fund raising

opportunities than reduced walleye limits and slot sizes.

The lake can support a relatively fixed number of pounds of predator fish. The question is; do we want Northern and Bass or more Walleyes? We must be smart, we fishermen have more impact than we realize. Remove the unwanted species and practice selective harvest on the walleyes. The Small Mouth Bass and Northern Pike played a key role and had a negative impact on Mille Lacs Lake. The Minnesota DNR will be proposing special regulations on Northern Pike that will allow you to keep 10 fish smaller than 21". The small northerns are tasty pickled. I am including the recipe that I like in the newsletter.



## Stocking ~ Donate to the Cause

When done well, stocking can work wonders. Hundreds of Minnesota walleye lakes would today offer little or no walleye fishing were it not for regular stocking. Let's help Lake Ida benefit from our donations!



## **Recipe from the President**

Who would have thought? I guess every great fisherman knows how he/she likes to prepare their catch!

Fish fillets, smaller Northern Pike and smaller

Largemouth bass are ideal. Do not debone the fish, the vinegar will dissolve them. I never debone them.

Salt brine, enough to float an egg

White vinegar Sliced onions

4 c. white vinegar

3 c. sugar

1 c. white sweet silver satin wine

1/4 c. pickling spice

Cut fillets into herring size pieces and put in salt brine for 48 hours. Drain and rinse with cold water. Cover fish with white vinegar for 24 hours in refrigerator. Gallon plastic zip lock bags work. Drain and throw vinegar away. Put layer of fish then a layer of sliced onion in containers until full. I use quart canning jars. Heat together 4 cups white vinegar and sugar until sugar is dissolved. Cool. Add wine and pickling spice. Pour over fish and cover jars. Fish must be covered at all times and kept refrigerated. Yields 3 quarts.

## **Invasive Weeds Go Away**

We still have some curly leaf pondweed in Lake Ida so we are treating it again this year. This will be the third year which is typical for treating this type invasive weed. Hopefully this will finally eliminate this problem. The curly leaf is only in the bay in District 1 (near Betsy Ross). It is treated with chemicals. The Ida Lake Association did not get a grant this year to help the cause.

### Got the Blues! And that's Good!

An extensive report on the health of our beautiful lake was completed in 2011. This report is available on our website for members to review. We have had volunteers taking water samples and

reading the clarity of the water for 17 years and have enough data to create a definitive trend line showing how our lake is doing. We continue to do the water sampling so that trends can be monitored into the future. Lake Ida is maintaining water quality (i.e. not improving or declining), but it is important that we ALL take pride in our lake!

As we all get ready enjoy outdoors this summer, make sure you locate your fire pit at least 50 feet awav from the lakeshore and remove ashes from the fire pit prevent the ashes from being blown or

washed into the lake. **Douglas County**Ordinance prohibits burning within 100 feet from the lakeshore.
