#### From The President

Many members have worked this year to carry out our mission to preserve and protect the serenity, quality and natural beauty of Lake Ida. Our enjoyment of this special environment depends on all of us, so thank you again.



At the Member Meeting May 25<sup>th</sup>, we will report on several association projects to protect the lake. All of us should do what we can on our own properties to help prevent runoff and its effects on our lake environment. Buffer zone plantings along the shore are one option. There is grant

money available from the Douglas County Soil and Water District for this, but they must be notified and review your plan before the work is started to qualify.

Last fall the association supported the stocking of 1,000 pounds of walleye fingerlings in the lake. The condition of our lake fishery has been an issue this year so at our meeting we plan to have a speaker from the DNR to report on the issue.

In June we hope to have the Lake Ida watershed study done and recommendations prepared.

## **Curly Leaf Pondweed**

Last year the DNR found more Curly Leaf Pondweed in our lake. The ILA treated 28 acres last spring and had another survey completed at the end of June 2018 after the treatment. AIS Consulting did the survey and found <u>no</u> curly leaf pondweed in the areas treated. However, to maintain the elimination of curly leaf pondweed, it is recommended that treatment run over a three-year period. Good news - Douglas County Land and Resources Management gave ILA a grant for 75% of the cost of survey and treatment of curly leaf pondweed this year.

#### **Organics Recycling Program**

Want to recycle your food waste and/or other products for organic recycling? You now can. A new **Organics Recycling Program** is available through Pope/Douglas Solid Waste Management.

At the Fall Meeting last year, Nathan Reinbold, Environmental Coordinator at Pope/Douglas introduced us to this new service of **Organics Recycling**. About 38% of our garbage is of the 'wet' variety of food waste. Examples that can be recycled our food scraps, fruit, vegetables, meat, fish, bones, eggs, dairy, peels, pits...and more! Currently, this food waste is put into a gas fired incinerator to dry this material out, so that it can be burned. Composting on the other hand becomes soil for farmers, and eliminates the CO2 from burning. How many of us clean fish and throw the remains into our garbage?

#### **Summer Fun**

Join in some fun without ever leaving your lawn chair! The 11th Annual Lake Ida Fourth of July Boat Parade will take place Thursday, July 4 (more information to come). Watch from shore, or decorate your boat and fall in line. Make sure you are a part of the tradition and fun celebrating at the lake!

#### **Please Be Courteous**

We all share the lake – with residents and visitors alike...please be courteous! Many boaters enjoy stopping for a swim at several areas around the lake. They have a right to use the water, but not to set foot on the land. Douglas County has established no wake zones, 300 feet from shore for eight area lakes, including Lake Ida. Litter! Goes without saying, please pick up after yourselves and keep garbage from flying out of your boats.

## **Dispose of Waste Properly**

Not sure what to do with your recycling or hazardous waste? Visit the Pope/Douglas Solid Waste Management website www.popedouglasrecycle.com or call and ask at 320-763-9340. Dispose of unwanted items safely!

#### **Beach Work**

Cleaning up your lake shore after the ice has gone out – please dispose of leaves and debris properly! Planning beach work or a landscaping project near your shore line or bank? Please contact Douglas County Land and Resource Management at 320-762-3863, to ensure that your project is in compliance with county regulations. Though major projects may require a conditional use permit, the departments will issue permits for smaller projects.

#### **Do Not Burn Near the Lake**

Did you know that burning leaves or wood near the lake destroys the organic matter releasing the phosphorus, which could be washed into the lake? Phosphorus entering lakes and rivers feed the growth of algae, bacteria, and other tiny organisms. Water bodies require some nutrients to be healthy, but too much can be harmful. When lakes receive an overabundance of nutrients, they can become polluted by excessive amounts of algae. Die-off and decomposition of algae blooms can reduce dissolved oxygen and suffocate fish and other aquatic life. Some forms of algae (blue-green) may produce toxins that can be harmful if ingested by humans and animals.

Please do NOT burn your leaves near the lakeshore. **Douglas County Ordinance prohibits burning within 100 feet from the lakeshore.** The only exception is a recreational wood-burning campfire. Make sure you locate your fire pit at least 50 feet away from the lakeshore and remove ashes from the fire pit to prevent the ashes from being blown or washed into the lake.

## **Fish Stocking**

After 2 years of being unable to obtain walleye for stocking, ILA observed the weigh-in and distribution of 1,000 lbs. of walleye fingerlings into our waters. Last year the DNR stocked 875,000 fry (teeny) and 11,000 yearlings (659 lbs.) and 20 adults. ILA has just over \$4,000 remaining in fund for this fall. Information and discussion will follow in the summer.

We all need to understand that there is little natural walleye reproduction in Lake Ida. The pan fish and the huge schools of shiner minnows will consume any fry that do hatch. We do not fully understand the long-term negative effect that Zebra Mussels will have. Ida had very few walleyes when this area was first settled. It was stocking that created

the excellent walleye fishing. Most of the funds committed to stocking does come from donations from dedicated fisher folks and local Sports Clubs.
